INVITATION TO BID

CONCRETING OF ROAD WITH DRAINAGE PIPE CULVERT INSTALLATION AT RUANTO ST., POBLACION 1, INFANTA, QUEZON

- 1. The MUNICIPALITY OF INFANTA, QUEZON, through the Budget for the Contract approved by the Sangguniang Bayan, 20% EDF, 2017, Concreting of Farm to Market Roads, intends to apply the sum of Six Hundred One Thousand Nine Hundred Ninety-One Pesos Only (Php 601,991.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 2017-0508. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The MUNICIPALITY OF INFANTA, QUEZON now invites bids for the Construction Projects. Completion 2. of the works is required within Forty-Five (45) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from MUNICIPALITY OF INFANTA, QUEZON and 4. inspect the Bidding Documents at the address given below during Mondays thru Fridays, 8:00 AM -12:00 NN and 1:00 PM to 5:00 PM.
- A complete set of Bidding Documents may be purchased by interested Bidders on August 16 to August 5. 24, 2017 up to 12:00 NN from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand Pesos Only (Php 1,000.00).
- It may also be downloaded free of charge from the website of the Philippine Government 6. Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before August 24, 2017. 12:00 NN. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- Bid opening shall be on August 24, 2017, 2:00 PM at the 3F Municipal Extension Building of Infanta, 8. Quezon. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- The MUNICIPALITY OF INFANTA, QUEZON reserves the right to accept or reject any bid, to annul the 9. bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
